1:30 - 2:30 Breakout Sessions

1. New Mexico Evidence Update: New Caselaw, Rules, and Recurring Issues Professor George Bach, UNM School of Law

1. Children's Law Workshop: Kinship Guardianship

This session will address best practices regarding kinship guardianship cases, current caselaw and statutory construction, and an overview of the interplay between kinship guardianship cases and children's law. This session will also discuss ICWA and answer questions about complying with ICWA in kinship guardianship cases.

The recent Supreme Court Order (April 12, 2019) consolidating the courts will be reviewed, and a wideranging discussion is expected concerning court relations, collegiality and the district courts' exercise of administrative authority over magistrate courts. Currently, the Third Judicial District Court is proceeding as a pilot program in the consolidation. Judge Perea, a former magistrate court judge, will speak to magistrate court issues and perspectives that can be anticipated.

Concrete examples of this cross-collaboration will be highlighted, with a brief time to share experiences with state and tribal courts working together on ICWA issues.
